#### Sub.: <u>PCI-Revision of Affiliation Fee from 2014-2015 academic session.</u>

Sir,

With reference to the subject cited above, I am directed to say that the  $93^{rd}$  Central Council of the Pharmacy Council of India in it's meeting held in July,13 has decided to raise the affiliation fee from 2014-2015 academic session as per the following details –

a)	D.Pharm course	-	From Rs.15,000/- to Rs.50,000/- per annum
b)	B.Pharm course	-	From Rs.15,000/- to Rs.100,000/- per annum

In view of above it is informed that –

- a) the revised fee should be sent from next financial year i.e.2014-2015.
- b) The fee should be sent only in the form of demand draft in favour of Pharmacy Council of India payable at New Delhi alongwith the duly filled in proforma which is enclosed herewith as **Appendix I.**
- c) Institutions running both D.Pharm. & B. Pharm. courses simultaneously has to pay separate DDs. Rs.50,000/- for D.Pharm. and Rs. 1,00,000/- for B. Pharm.
- d) Mentioning file number of your institution is very important while submitting fees. For file number please refer to any of Council's communication sent to you, it is on top left hand side. Please note that-
  - Diploma file number starts with 17-
  - Degree file number starts with 32-

e) You may also refer to Council's website **www.pci.nic.in** under the lists of approved u/s12 or approved for conduct of course as per approval status of your institution. The file number is mentioned in the column of S.No. of your institution. For example –

i) The Council has decided to charge an "Inspection Fee" from January, 2005 in respect of new diploma and degree institutions approaching the Council for approval as per the following details

- Additional inspection if required	Rs.15,000/- per inspection, per course (diploma/ degree) till approval is granted by the Council		

- ii) This Inspection Fee from new institutions will be in addition to Affiliation Fee which is as under :
  - a) D.Pharm Course Rs. 50,000/- per annum b) B.Pharm. Course - Rs.1,00,000/- per annum
- **iii)** Once the new institution is granted approval, no Inspection Fee will be charged for inspection for further extension of approval and only Affiliation Fee will be charged by the Council as per above details.

In view of above, you are requested to forward per return of mail a Demand Draft (not Cheque) in favour of Pharmacy Council of India, payable at New Delhi of –

- i) Rs.25,000/- as Inspection fee
- ii) Rs.50,000/- as Affiliation fee for D.Pharm Course.
- iii) Rs.1,00,000/- as Affiliation fee for B.Pharm Course.
